Give the correct amount of notice in writing

Make sure you understand the minimum notice period that applies to your rental situation. A tenant should check what costs may apply if they end a tenancy early, such as rent and maintenance until a new tenant is found.

- Landlord ending a tenancy, including evictions
- Tenant ending a tenancy
- Mortgagee ending a tenancy



Move out of the home by the end date

A tenant should do everything they can to move out by the date on the termination notice. A tenant must return all keys and other security devices such as garage door remote or carpark fob.

Leave the home clean and empty

A tenant must make sure they have:

- removed all their belongings
- left the home in a similar condition to when they moved in
- repaired, or paid the cost of repairing, any damage (beyond fair wear and tear).
- a copy of the condition report completed when they first moved. This can help with any disputes about the condition of the home.

Conduct a final inspection of the property with the landlord or agent

The landlord must do a final inspection of the property once it's empty. The landlord must give the tenant(s) a reasonable chance to be at the final inspection. For more information see property condition reports.

Getting the bond back

At the end of the tenancy the bond must paid out. The tenant can help this process by leaving the property empty and clean by the specified date.

The landlord can make a claim against part or all of the bond if the tenant does not leave the home in a similar condition to when they moved in. The landlord can also make a claim for other costs or money owed such as for missed rent, bills or damage.



A successful move out begins with thoughtful preparation, and this section highlights how essential that groundwork is for tenants. By carefully assessing the condition of each area, planning your cleaning tasks and addressing any minor repairs, you can ensure the property is returned in an acceptable state. Reviewing your lease terms and allowing enough time to complete each requirement also helps prevent unnecessary pressure as the vacate date approaches.

Preparing the rental thoroughly not only supports a smoother final inspection but also improves the likelihood of receiving your full bond refund. With clear communication, early planning and a consistent approach to completing each task, tenants can confidently finalise their responsibilities and leave the property in a well maintained and satisfactory condition.

2. Understanding Tenant Responsibilities and Inspection Standards

Inspections

• Your Housing Services Officer will attend your allocated property to complete a property inspection up to two times per year.



- The inspection is for the purpose of making sure that you are maintaining the property in accordance with your tenancy agreement.
- You will be provided notice prior to the inspection.
- If you are experiencing difficulties maintaining the property, services from local shires or community groups may be able to help. Ask your Housing Services Officer how to find some of these services.
- Your Housing Services Officer can also visit the property throughout the year to see how you're going. These visits are outlined in your tenancy agreement.

Moving out

 You will need to let your Housing Services Officer know that you are vacating the property a minimum of 21 days before. The property must be left clean and tidy and in good repair.

- If you do not do this, Housing and Works may charge you for cleaning up or for repairing damage. This is called tenant liability.
- Your Housing Services Officer will compare the condition of the property when you moved in, to the condition when you vacated.
- They will look at the property condition report that you filled in when you first moved in.



Meeting tenant responsibilities and understanding inspection standards are key parts of maintaining a rental property and ensuring a smooth transition at the end of the lease. During the tenancy, scheduled inspections usually conducted twice a year with prior notice—allow the Housing Services Officer to check that the property is being cared for as agreed. Support services may be available for tenants who need assistance with upkeep.

At the time of moving out, tenants must provide at least 21 days' notice and return the home clean, tidy and in good repair. The final condition is assessed against the original entry report to determine any required charges.

Understanding tenant responsibilities and inspection standards reduces uncertainty and helps secure a smooth move out. Regular inspections, usually up to twice a year with notice, allow the Housing Services Officer to identify maintenance needs early so tenants can address issues

before they escalate. Tenants should keep records of routine upkeep and seek assistance from local services if maintaining the property is difficult.

When preparing to vacate, giving at least 21 days' notice and ensuring the property is clean, tidy and in good repair are essential. The final inspection compares the vacated condition to the original entry report to determine any tenant liability for cleaning or repairs. By following lease requirements, practising consistent maintenance and communicating with the Housing Services Officer, tenants can minimise disputes, avoid unexpected charges and improve the chance of a full bond refund.

3. Essential Tasks to Complete Before Your Final Inspection

As a renter, moving out of your current space at some point is inevitable. However, it's not going to be as simple as packing up your belongings and moving to the next spot. You have a lot to do, and the task of moving out of a rented spot can be daunting, not to mention finding the best moving company for you.

Why Complete All The Items on This Checklist?

When you moved in, it's more than likely that you were required to put down money as a security deposit, which may have been upward of a month's rent.



Landlords charge security deposits to ensure that, if anything was damaged during the duration of your occupancy, they are guaranteed that the funds are available for them to make the necessary repairs before the next tenants move in. However, if you've managed to successfully make it through your lease without causing any damage to the rental, it's important that you get that money back.

In The Bedroom(s)

Repaint the room back to its original color, and remove any temporary wallpaper that you
may have put up.

- Remove all nails, hooks or mounted mirrors from the walls and ceiling, and follow your lease agreement as far as how to handle filling any holes.
- Check for scuff marks in areas where the bed and other furniture meet the wall, and paint over them if needed.
- Ensure that the closets are emptied and cleaned.



In The Bathroom(s)

- Disinfect and clean the showers, bathtubs and sinks, paying special attention to soap, lime, rust or other types of buildup that may be clinging to any metal hardware.
- Clean all mirrors using a glass cleaner and a streak-free rag.
- Remove any hair from in and around the drains and ensure there are no clogs.
- Use a cleaner and a brush to clean the inside of the toilet, and use a disinfectant on the outside.
- Repair any broken tiles.
- Remove any mold or mildew that may have grown over time.
- Clean the grout and tiles.

In The Living / Family Room

- Check the walls for any scuff marks, and repair any that are found.
- Check for and remove any scuff marks on the floor that may have been caused by shifting furniture.
- Remove any remaining wood and ash from the fireplace, and be sure the flue is shut.



In The Kitchen

- Wipe down the walls, paying special attention to the backsplash and other areas surrounding the stovetop where grease and food buildup could be.
- Clean both the insides and outsides of cupboards, drawers and pantries. Consider using a vacuum hose extension to remove any stubborn crumbs that are not easily wiped away from the corners.
- Remove, donate or throw away anything remaining in the refrigerator and freezer, and wipe both the inside and outside of the appliance clean with a disinfectant cleaner. Don't forget to dust the top.
- Defrost the inside of the freezer.
- Turn off the ice maker.
- Sweep and mop the floor.
- Clean both the inside and outside of the microwave.
- If the microwave is built-in and suspended, be sure to wipe the bottom clean.
- If the microwave sits on a countertop, be sure to clean underneath it to remove any crumbs or debris.

- For an electric stove top, remove any food debris and wipe the glass clean.
- For a gas stove top, remove and clean on, around and under the burner grates.
- Clean the inside of the oven by wiping down the inside racks and drip trays and removing any food particles.
- Clean both the inside and outside of the dishwasher, being sure to remove any particles of food that may have collected on the bottom or in the filter.
- Clean out the garbage disposal to ensure that no food is stuck inside and no smell will linger.
- If you're able to safely move them, sweep behind and underneath the stove and refrigerator.

Don't Forget

Here are some last-minute tasks that you may forget, even if your apartment looks spotless.



- Dust and wipe down the ceiling fans and air vents in all rooms.
- Dust and wipe down any built-in plastic or wooden blinds.
- Dust and wipe down any window sills.
- Wipe down all windows from the inside using a glass cleaner and a streak-free rag.
- Dust away any cobwebs from the corners and ceilings of all rooms.
- Wipe down all door frames and ensure all locks are functioning normally.
- Sweep patios, porches and balconies to remove any dirt and debris.

- For any rooms with carpet, be sure to vacuum and check that it is free of rips, stains and other damages.
- For any rooms with tiles or wood floors, be sure to sweep and properly clean them.
- Clear out and wipe down the insides of any linen or storage closets.
- Wipe down all light switch plates and doorknobs with a disinfectant.
- Replace any burnt-out lightbulbs.
- Take out and dispose of any last-minute trash and recycling.
- Check to be sure that the washing machine and dryer are both empty, and remember to clean out the lint catcher.

Myth: "Vacate Cleaning is Just a Regular Cleaning Session"

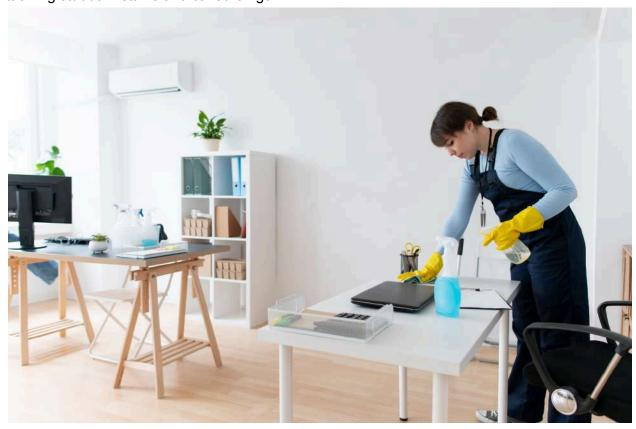

The main objective is to meet the landlord's cleaning expectations to secure full bond money during the end of a tenancy.

Myth: "DIY Cleaning is As Effective As a Professional Service"

Reality: Most renters prefer DIY cleaning before the final rental inspection and end up losing a significant part of their bond money. According to the tenancy laws and agreement, renters must return the property in a pristine state, i.e. reasonably clean. To achieve that spotless shine, you need highly-trained vacate cleaning Perth professionals as they have years of experience in tackling stubborn stains and caked-on gunk.



You may not have the proper tools and products to clean hard-to-reach areas, but professionals do. They bring heavy-duty vacuum cleaners, assorted brushes, sponges, telescopic dusters, de-greasers, mops, etc, to match the highest cleaning standards without leaving a sign of dirt and grime behind.

Tip: If you are tight on budget, do proper research and compare quotes to book a professional service within your estimated budget.

Myth: Professional Cleaning Means Full Bond Return

Reality: A professional and meticulous move-out cleaning only increases the chances of securing the bond money. Of course, tenants should focus on attention-to-detail cleaning, adhering to the landlord's expectations, but consider other crucial factors as well.



Most tenants lose their bond money due to property damage issues, mould infestation, outstanding rent, breaching the lease agreement and other reasons mentioned in the legal document. So, it is good to read all the tenant roles and responsibilities during and at the end of your lease and refer to your property condition report to avoid bond deductions and penalties.

Myth: You Need Expensive Cleaning Products For Spotless Results"

Reality: Store-bought expensive cleaning solvents and disinfectants won't determine the success of your rental inspection. On the contrary, these products contain harmful chemicals and VOCs that can cause indoor air pollution, leading to potential health hazards and respiratory issues.

The reality is that you can achieve the same level of cleanliness using affordable and eco-friendly products. Using white vinegar, baking soda, lemon, castile soap, hydrogen peroxide, dish soap, etc can help you de-grease oven, microwave, bathroom tiles, windows inside and outside, carpets and other surfaces efficiently. You can promote a healthy and hygienic indoor environment without using fancy products.

Myth: Outdoor Areas Are Not Included

Reality: Don't fall for this myth, as it can lead to unwanted deductions in your bond money. Exterior areas are as important as interiors when preparing your rental property before the final move-out. Many companies include patio areas, garage walls, exterior windows and decks in the pre-approved checklist for a detailed vacate cleaning Perth. A clean and well-maintained exterior area can enhance the property's overall curb appeal, making it easy to attract new occupants.



You can also outsource pressure washing as an additional service to impress your landlord or property manager. It is good to ask necessary questions about bond cleaning inclusions and exclusions before making the final decision.

If you want to move out check first what kind of tenancy agreement you have.

If you have an ongoing periodic agreement

- You must tell the landlord at least 21 days before you want to move out.
- You might be able to move out earlier if the landlord did not stick to the tenancy agreement.

If you have a fixed term agreement

- If you want to move out before the end date you might have to pay your landlord a fee. This is called a break fee or compensation.
- Sometimes you can move out earlier and not pay the fee. It might be good to talk to a TAAS about this.
- If you want to move out at the end date you must tell the landlord
 - 14 days before you want to move
 - At the latest on the end date
- After the end date your fixed term agreement becomes an ongoing periodic agreement
- You then must tell your landlord 21 days before you want to move out.



Effectively coordinating your move out day is crucial for a smooth and stress-free transition from your rental property. By planning a clear timeline, prioritising essential tasks such as packing, cleaning, and repairs, and organising each step in advance, tenants can manage their responsibilities efficiently. HOW DO YOU GET YOUR BOND MONEY BACK WHEN YOU MOVE OUT?

1. Do an inspection

Check through the place with the landlord or agent. Get someone to be there with you.

Fill in the condition report with the landlord or agent. You should have filled in a condition report when you moved in. You need to do another one when you move out – then the two reports can be compared.

Take some photos in case you have trouble later.

The bond is your money unless the landlord proves otherwise.

2. Get a Claim for Refund of Bond Money form

You can get the claim form from:

NSW Fair Trading – phone 1800 500 330 (free call), or your landlord or agent, or any real estate agent, or Google 'Refund of Bond Money form NSW'

Or, if you manage your bond using Rental Bonds Online, you can claim your bond using that online system (see below).

Call your local Tenants' Advice and Advocacy Service if you need help.



3. Sign the claim form

Put your bank account number on the form so the bond money can go straight into your account.

Write down a forwarding address (where you will be moving to).

Do not sign a blank claim form. Make sure you know what the form says before you sign it.

4. If you can't agree with the landlord or agent about the bond, you can send the claim form directly to the Rental Bond Board.



A successful bond refund and smooth property handover depend on careful preparation and awareness of tenant responsibilities. Tenants who take the time to clean thoroughly, complete minor repairs, and maintain the property throughout their tenancy are more likely to avoid disputes during the final inspection.
